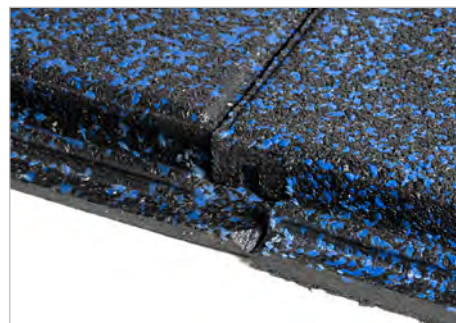

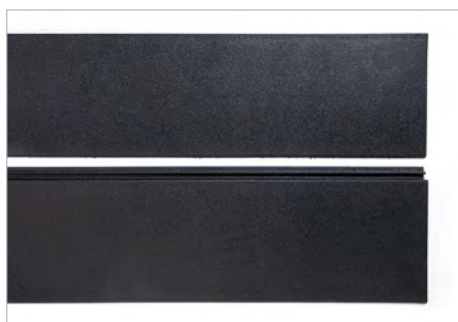
TILE EDGE - MALE SIDE

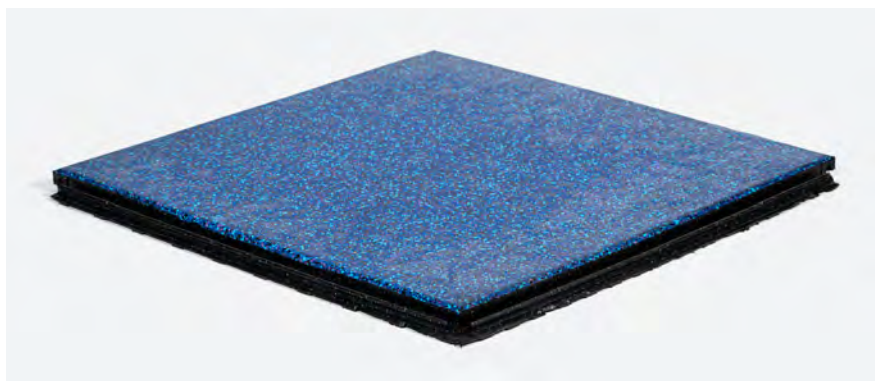

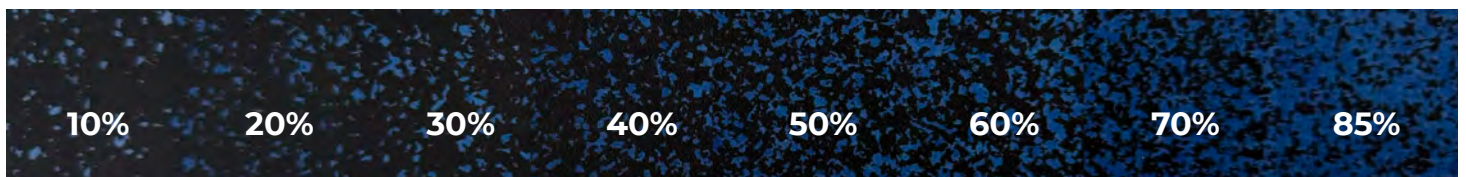

ROUTINE CLEANING AND INSPECTION

Recycled Rubber Tiles should be visually inspected and cleaned on an established interval. The frequency will depend on the environment and level of use. Millennium Molding, Inc. recommends monthly inspections and cleaning intervals.

CLEANING AND MAINTENANCE

Standard Cleaning and Maintenance Options

- Sweep surface with a stiff bristle outdoor broom to remove larger debris and accumulated dirt and dust.
- Spray the surfacing with clean water using a standard hose to remove contaminants from the surfacing as well as the pores of the system.
- Vacuum the surface with a commercial grade vacuum to remove loose particles from the surface, transitions, joints and pores of the system.

CLEANING STAINS

- Use mild cleaning soap with a soft bristle brush or mop to scrub the affected area.
- Use clean water to thoroughly rinse any area covered with soap residue.

ANNUAL MAINTENANCE GUIDELINES

Remove any debris or other loose material.

Broom the entire surface of the system.

Vacuum the entire surface of the system.

- Spray the surface with clean water.
- Use a mild cleaning soap with a soft bristle or mop and scrub the surface in 5 ft x 5 ft sections. Thoroughly spray the affected area with clean water to remove any soap residue.
- Continue cleaning with mild soap and water until the entire surfacing system has been cleaned.

LIMITED WARRANTY ON MATERIAL

Millennium Molding, Inc (MMI) warrants to you, the original owner of the property that the MMI product, will comply with the technical specifications and be fit for those applications as set forth in the Manufacturer published technical and promotional materials at the time of sale and the product will be free from defects in materials and workmanship (subject to the limitations set forth below) for a period of ten (10) years from the date of purchase from the Manufacturer or its authorized dealer.

MMI LIABILITIES

MMI's sole liability under this limited warranty shall be the repair or replacement, excluding installation, freight and other costs, at its options, of product strictly according to the procedure set forth below.

EXCLUSIONS FROM COVERAGE

This limited warranty does not cover any of the following conditions:

- 1 Products which have been improperly installed
- 2 Products installed over improperly prepared sub-surfaces
- 3 Products installed over a sub-surface not specifically approved by the Manufacturer
- 4 Normal or excessive wear and tear of Product
- 5 Surface appearance or color of Product
- 6 Products subject to misuse, abuse, neglect, chemical cleaning or contact not specifically approved by Manufacturer

NOTICE OF CLAIM

To exercise this limited warranty, Manufacturer must be notified within fifteen days of any occurrence giving rise to a claim and prior to installation, given the opportunity to inspect the Product, and have issued direction to the original purchaser respecting disposition of Product to be replaced under this limited warranty. Purchaser shall comply with all reasonable requests of Manufacturer in the administration of warranty claim.

SOLE AND EXCLUSIVE WARRANTY
